Board Meeting Minutes, January 29, 2013

The Meeting was called to order at 7:10 PM by Bryan Casebolt.

Jim Wooldridge, Jr. presented a treasurer's report. Reported back to the board that historical P&L reports are being analyzed to find areas of improvement for the clubs financial health.

Club meeting minutes from previous meeting distributed for review.

Pete Rodriquez presented track maintenance report.

- Reported on the state of club headsets. 13 headsets in total, with 8 fully functional at this time. Needed repairs will be reported back after further investigation.
- Race flags have been inventoried and checked for usability. No new flags needed at this time.
- One golf cart possibly needs battery repair/replacement. Roger Culver checking into this before Challenge of the Americas.

Race day spectator gate will be moved West of the spectator area. Russ Anderson will check into having a sign made to direct people to the new gate location. Cliff Kujala suggested the use of flags on the fence at the gate opening to attract attention. Pete will expand the gate to a larger opening using supplies on hand.

Gary Quattrocchi has offered to sponsor championship trophies for Shifter Light and Heavy. Approved unanimously by BoD vote. Russ will ask Curtis Ruth of Innovative Karting if the offer he previously made on PKRA forums for can be moved to Shifter Junior.

Qualifying format discussed. Some members have requested open practice sessions. Board decided it will be necessary to evaluate current format for more time before a change can be made.

Flagman errors discussed. Flagman will be instructed to use number board when issuing driver specific notices.


Pete suggested that we look into printing more shirts for race day employees.
