Race Logistics/Procedures – Next Race – Nov 17 Winter Race #2

- Status on finding a Tech Inspector. Hard to get someone to commit may have to cross train two. Bernie still looking. If anyone has suggestions, get them in touch with Bernie.
- Failing to Go Through Tech How do we know? Apparently, we didn't keep track very well for Kid Karts. We need a little more communication from the tower, though they are busy. Perhaps manual scoring could call with which karts. We also can't close out the race until tech of the last class is complete.

Finance

- Balance: \$48,816 as of 11/10/2019
 - Need \$3,000 more for Awards Banquet
 - Still owe Jon Casey for light work could be \$5-\$7,000
 Paul will work to get a brighter lighting element.
 - Need \$5,800 or less for removing/moving free lights (just stacking/storing for now.
 - Need \$\$ for moving bleachers. Bleacher company quoted a high price for large set. Less than \$3,000 to move the two small sets and can move intact. Can use

the current B grid slab for one set. Ted would then get the two high sets.

County Lease Renewal

- County Proposed Agreement
 - PKRA Rate Schedule Paul is still negotiating.
 - Contract Paul negotiating on this as well.

Tire Contract

- Tested 50 laps Nov 10 6 different compounds. Will be narrowing down. Goal is that they could be used 3 races.
- Plan to discuss tire alternatives with membership at the Dec 9 meeting. Weighting of factors, including performance, durability, and cost to members, will be discussed.
- A new tire contract would begin May 1, 2020

New Registration Room

- We will begin using the new registration room for winter race #2 on Nov 17.
- We will need the side entrance to the covered area off of pit spot #1 open to allow access to the registration room. We will allow food vendors to use the front only. Matt England will need to move over to #2 (or to another open pit spot of his choice).

Decisions from Closed Board Meeting

- The decision was made to prohibit pets at PKRA. Only legitimate service animals will be allowed.
- Some disciplinary matters were discussed with some penalties imposed.
- The board gave specific race officials the authority to eject individuals if necessary due to abusive language or violence: Tech, Scales, Grid Boss, Race Director, Assistant Race Director. The Race Director does not need to be called away from the race for off the track incidents.
