- NKA Rule Set

- "Junior" and "Rookie" Class restrictions (prevents Junior 2 running with seniors – effects Tag100 Jr2 and Shifter Open Jr2 classes). Bernie has contacted and we can run Junior 2 with Senior and Junior 1 with Junior 1
- A number of questions sent to NKA, but rules changed for 2020, so we'll need to review.
- Add back 400.5 rule for CIK-FIA Bodywork? We removed this a few years ago since it was covered in IKF rules, but it is not covered in IKF. Yes
- IKF Numbers were a minimum of 5" high, whereas NKA says 6". Should PKRA override to 5" to allow folks with existing graphics to be legal? It's hard to fit 6" numbers on a side pod. IKF had the panel minimum of 7 X 7, whereas NKA is 7" high, but 9" wide. Yes. Contrasting colors, and 7X7
- Kid Kart sub-classes
 - Change to one registration class "Kid Kart"
- Change to qualifying grid in order of practice times.

Competition Committee Report

- The competition committee recommended using the NKA points system, which is slightly different (skewed to giving more points to top finishers and less to lower finishers). The board approved.
- Proposal for shifter kart classes:
 - Shifter ROK Pro Invitational class at 395 lbs expect competitive drivers only, but no formal licensing or approval required. Age 15+
 - Shifter Sportsman: Honda 385, ROK 395, KZ & SSE 410. Age 12+
 - Would leave a row or two separation between the two classes, unless there is enough to split them out.
 - Advertise as mini-series with 5 races with 1 drop, and would select which 5 races to participate in (the longer configurations). This would still be a non-championship class for PKRA, but they would arrange for their own series trophies. No per-race trophies.

- New "Free" Bleacher Plans. Will need permits. Civil, Flood, City, County. Estimates: Structural design maybe \$2,000. ADA Compliance (additional ramp and mods to existing ramp) \$5,000. Footing/Foundation \$8,000. Sitework to place. Could be a year lead time.
